G.S.R.....In exercise of the powers conferred by the proviso to Article 309 of the constitution and in supersession of the office of the competent authority under the [Smugglers and Foreign Exchange Manipulators (Forfeiture of Property) Act, 1976 and Narcotics Drugs and Psychotropic Substances Act, 1985], under the Ministry of Finance, Group 'A' and 'B' posts Recruitment Rules, 2003, in so far as they relate to the posts of Joint Commissioner and Assistant Commissioner, except as respects thing done or omitted to be done before such suppression, the President hereby makes the following rules regulating the method of recruitment to the posts of Joint Commissioner and Assistant Commissioner in the Office of the Competent Authority and Administrator under the [Smugglers and Foreign Exchange Manipulators (Forfeiture of Property) Act, 1976 and Narcotics Drugs and Psychotropic Substances Act, 1985], under the Ministry of Finance:-

1. **Short title and commencement.** – (1) These rules may be called the Ministry of Finance (Department of Revenue) Competent Authority and Administrator (Group 'A') Recruitment Rules, 2026.
2. **Number of posts, its classification and scales of pay.**- The number of the posts, their classification attached thereto, shall be as specified in columns (2) to (4) of the schedules annexed to these rules.

(2) They shall come into force on the date of their publication in the Official Gazette.
3. **Method of recruitment, age-limit, qualifications, etc.**- The method of recruitment, age-limit, qualification and other matters relating thereto shall be as specified in columns (5) to (13) of the schedule.
4. **Disqualification-** No person,
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Power to relax-** where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
6. **Saving-** Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Schedules Casts, the Schedules Tribes, Ex-

Service men and other special categories of persons including other Backward classes and economically weaker section in accordance with the orders issued by the Central Government from time to time in this regard.
